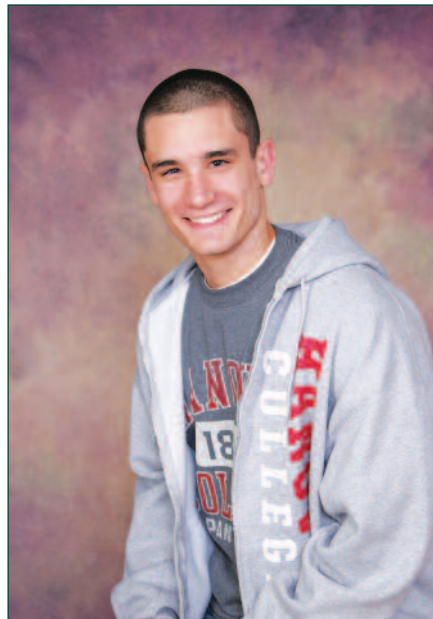

The mission of The Portland Foundation is to enhance the quality of life for the people of Jay County, Indiana, now and for generations to come, by building community endowment, effecting significant impact through grantmaking and providing leadership on key community issues.



## 2009 SUMMER GRANT AWARDS

The Board of Trustees of The Portland Foundation has approved grants totaling **\$20,743** for six Jay County projects for the 2009 summer grant cycle.

**Community and Family Services - \$2,574** for support of the organization's Heartlite energy assistance program.

**Jay Community Center - \$1,800** for upgrade of the Center's website.

**Jay-Randolph Developmental Services - \$3,969** for renovation of the organization's Community Fitness Walk.

**John Jay Center for Learning - \$10,000** towards purchase of storm windows for the John Jay Center. \$458 comes from the Fund for a More Attractive Community, a field of interest fund dedicated to the beautification of Portland. The remainder comes from unrestricted funds.

**LEAD-ECI - \$400** for a partial scholarship for a Jay County resident to attend the organization's leadership training.

**Salvation Army Jay County Unit - \$2,000** for basic human needs assistance for Jay County residents.

**The next grant application deadline is January 6, 2010 by 5 p.m.**

## SUMMER TEACHER CREATIVITY MINI-GRANTS AWARDED

The Board of Trustees of The Portland Foundation has approved Teacher Creativity Mini-Grants totaling **\$1,150** for seven projects for the second half of 2009. The mini-grants are to help cover the cost (\$250 or less) of creative learning experiences which teachers feel are important to their students, yet are outside the budget of their school.

This program is funded by the Virgil and Josephine Thomas Educational Fund and serves to allow teachers to become more creative in their teaching styles and methods, without being hindered by cost.

## SUMMER SCHOLARSHIP PROGRAM

The Board of Trustees of The Portland Foundation has approved scholarships totaling **\$20,540** for eighteen Jay County residents for the summer 2009 scholarship cycle.

**The Altrusa Club of Portland Scholarship** is awarded annually to a Jay County resident who is a non-traditional student. **Kari Brotherton** will receive a one-time award of \$180.

**The Janet B. Arnold Memorial Scholarship** is awarded annually to a Jay County High School graduate who is a college junior or senior and is majoring in elementary education. **Allison Fullenkamp** will receive a one-time award of \$250.

**The Alwyn Carder Scholarship** is awarded annually to a Jay County resident who is a college junior or senior and is majoring in architecture, history, or education. **Mason Shreve** and **Britney Shawver** will each receive \$3,000 payable at \$750 per semester for four semesters and **Andrew Pinkerton** will receive \$1,500 payable at \$750 per semester for two semesters.

**The John Jay Center for Learning Scholarship** is awarded to a Jay County resident who is pursuing a degree through the John Jay Center. **Abigail Bushee, Elizabeth Franks, Kari Griffith, Deborah Howell, Dawn Johnson, Susan McIntire, Angela Nichols,** and **Jodi Scott** will each receive a one-time award of \$350.

**The Robert and Helen Brown McCreery Scholarship** is awarded annually to a Jay County High School graduate who is majoring in either engineering or computer science at Purdue University. **Kelsey Bone** will receive a one-time award of \$200.

**The Jerry R. Pierce Memorial Scholarship** is awarded annually, with preference given to employees and descendents of employees of W & M Manufacturing, Pier-Mac Plastics, and Accelerated Curing. **Thomas Bowen, David Jones, Kyle McCabe,** and **Phillip Powell** will each receive a one-time award of \$2,400.

# LILLY COMMUNITY SCHOLARSHIPS

## Helping Students Build Dreams

Since 1998, The Portland Foundation has awarded 25 Lilly Endowment Community Scholarships to Jay County High School graduating seniors. The scholarship provides full tuition, required fees, and \$800 per year for books and equipment for up to four years of full-time undergraduate study. The Foundation recently contacted the 15 recipients who graduated between 1998 and 2004 to inquire about their current status. Information on seven of the individuals was featured in our spring 2009 newsletter. Updates on the other eight Lilly Scholars are listed below.

**Natalie Hosier** became a Lilly Scholar in 2002. Natalie attended Butler University and received her degree in 2008. She is currently seeking her Doctoral degree at Butler. She lives in Fishers and is employed as a pharmacist at Walgreens.

**Emily Padilla** also became a Lilly

Scholar in 2002. Emily attended Huntington University, receiving a degree in biology in 2006. Emily lives in Rochester, Indiana where she is employed as a customer service specialist for Equity Residential Housing in Indianapolis.

**Ashley Muhlenkamp Stachler** was one of three Lilly Scholars in 2003. Ashley attended Butler University and received a degree in accounting in 2007. She was married in 2008 and is employed in Indianapolis as a public accountant.

**Alison Muhlenkamp** became a Lilly Scholar in 2003. Alison graduated in 2007 from Indiana Institute of Technology with degrees in accounting and business administration management. She lives in Minnesota where she is employed as an accountant. She is engaged to be married later this year.

**Amber Golden Ford** also received a Lilly Scholarship in 2003. Amber

received a degree in accounting in 2007 from the University of Indianapolis. She lives in Avon, Indiana with her husband and currently works for Habitat for Humanity of Greater Indianapolis.

**Jay Muhlenkamp** became a Lilly Scholar in 2004. He attended Purdue University and received a degree in AgriBusiness Management in 2007. Jay is employed in Jay County as a Farm Manager.

**Emily Lyons** received a Lilly Scholarship in 2004. She received a degree in computer science from DePauw University. She is currently a graduate student and teaching assistant at Indiana University.

**Adam Ford** also received a Lilly Scholarship in 2004. Adam graduated in 2008 with an engineering degree from Rose-Hulman Institute of Technology. He is employed as an associate engineer at Rolls-Royce in Indianapolis.

# 2009 HARVEST HOPPERS

## October 14 & 20 and November 5 & 10

Last October, the Friends of Jay County Agriculture introduced the Harvest Hoppers Initiative. Two semi tractor trailer rigs were driven to several farming locations around the county. Farmers had the opportunity to turn their augers on for as long as they wished. Through the generosity of many farmers and farm families, **\$12,300** in grain was contributed to the Friends of Jay County Agriculture funds. The purpose of these funds is to provide support to those organizations which most positively impact the field of agriculture in Jay County.

This year **Harvest Hoppers** will be held on **October 14 & 20** for beans and **November 5 & 10** for corn.

There are three ways to participate in this project:

- **Harvest Hoppers** contribution into our semi
- Gift of grain at one of the local terminals
- Cash gift to the Foundation

The Friends of Jay County Agriculture group has set a goal of \$500,000 for the initial endowment. If gifts from producers, land owners, and businesses reach this goal, a **\$25,000 grant distribution** could be made to the Jay County Ag Community every year!

As of July 31, 2009, the balance of the Friends of Jay County Agriculture Endowment was \$34,000, while the total in the Friends of Jay County Agriculture Fund was \$3,650.
