- The scholarship will provide full tuition, required fees and a special allocation of up to \$900 per year for required books and equipment for four years of full-time undergraduate study leading to a baccalaureate degree at any Indiana public or private college or university accredited by the Higher Learning Commission of the North Central Association of Colleges and Schools
- The program is open to all members of the class of 2014 who are Jay County residents and have graduated from a regionally accredited Indiana high school
- The scholarship applicant must have been accepted to pursue a full-time baccalaureate course of study in the fall of 2014.
- The scholarship applicant must have a minimum 3.5 grade point average on a 4.0 scale at the time of application
- The scholarship applicants are scored in the areas of Academics, Financial Need, Activities, and Written Essay.
