This application is used for all of The Portland Foundation's 2016 summer scholarships. Each scholarship is unique. SCHOLARSHIP SELECTION PROCESS:

The scholarship committee is composed of board members of The Portland Foundation and members of the donor family when applicable. The committee reviews all applications turned in by the deadline. Each student is numerically scored based upon the following criteria:

1. Academic accomplishment
2. Financial need and resources available to the student
3. Activity and involvement in school, work and the community
4. Essay content and competency (when applicable).

All applications will be scored without the committee knowing the identity of the applicant. Names should only appear on the first page of the application.
