## **Grant Guidelines**

## The Portland Foundation Women's Giving Circle

#### OUR MISSION:

The mission of The Portland Foundation Women's Giving Circle is to build a community of women philanthropists through the pooling of knowledge and resources for the purpose of providing grants to Jay County organizations and initiatives that address mutually-agreeable issues.

## **GRANT FOCUS FOR 2025 (PLEASE READ!):**

During 2025, the Circle will award grants which focus on enhancing the capacity of Jay County's not-for-profit organizations to support programming that addresses needs for Jay County. Applicants should be requesting grant support in the amount of at least \$5,000. For 2025, the Circle's goal is to award one \$5,000 grant, with <u>potential</u> finalists to receive a lesser amount.

#### WHO WE FUND:

The Women's Giving Circle makes grants to tax-exempt 501(c) organizations operating or proposing to operate programs for the benefit of Jay County residents.

#### THE FOLLOWING ARE EXCLUDED FROM CONSIDERATION:

- Organizations for religious or sectarian purposes
- Make-up of operating deficits, post-event or after-the-fact situations
- Endowment or capital projects and campaigns
- For any propaganda, political or otherwise, attempting to influence legislation or intervene in any political affairs or campaigns
- Dinner galas, advertising or other special fundraising events

### **HOW TO APPLY:**

- Completed, computer-generated, application forms should be sent electronically to the Foundation's Program Officer Jessica Cook at <a href="mailto:jcook@portlandfoundation.org">jcook@portlandfoundation.org</a>
- Applications that do not contain all of the requested information may not be considered. If requested information is not available, an explanation is required.
- Applicants are encouraged to contact Foundation staff with questions or if assistance is needed.
- Applicants representing local 501(c) organizations should request \$5,000 for programs/projects that support Jay County

#### PROPOSALS SHOULD INCLUDE:

- Electronically completed application. Handwritten, or printed applications <u>will not</u> be accepted
- Copy of IRS determination letter confirming 501 (c) tax-exempt status (if not already on file with the Foundation)
- Most recent financial statement, including budget and year-to-date income & expenses
- Board of Director's list

#### SUBMITTING THE APPLICATION:

- Grant applications must be received via email to <u>icook@portlandfoundation.org</u> on July 11, 2025 to be considered.

#### APPLICATION REVIEW:

- All applications are reviewed by Foundation staff for completeness and to insure they fit within the general guidelines.
- All applications are then reviewed by the Giving Circle Grant Evaluation Committee
- The Grant Evaluation Committee presents its recommendation to the Foundation Board of Trustees and the Giving Circle Executive Committee
- Final determination of grant awards is expected to be in September 2024 at the Women's Giving Circle Grant Event, where WGC members vote on a grant recipient. If your organization/project is recommended for funding, we ask that a representative attend the event and be prepared with a short presentation about the organization/project.

#### AWARDS:

The Women's Giving Circle anticipates that it will award a grant of \$5,000 to one organization with potential smaller grant awards to finalists during 2025.

#### **EVALUATION:**

All grantees will be expected to submit a written report when the funded project is completed or at the conclusion of the grant period. Guidelines for this report will be included with your grant award. You will not be eligible to receive another grant from the Women's Giving Circle until this evaluation is received.
